●AMPLE STOCK WITH NAFED TO KEEP PRICES DOWN

Chana production hit by above-normal Feb heat

New Delhi, March 1

THE PRODUCTION OF chana (gram), a key pulse variety, is likely to decline by around 10-15% from the last year output of 13.5 million tonne (MT) because of early maturity due to above normal temperature which prevailed in key growing states of Rajasthan, Madhya Pradesh and Gujarat last month.

Trade sources said that while the harvesting of chana on a large scale is expected to begin by the end of this month, there are reports of early maturity of the crop because of record temperature witnessed last month.

In February, monthly average maximum temperatures across the country were the highest since 1901.

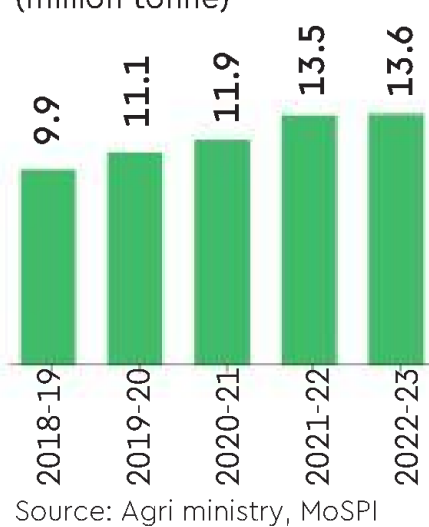
The agriculture ministry, in its second advance estimate of foodgrains production for 2022-23 crop year (July-June), has estimated chana production at a record 13.6 MT.

Officials said that they are still assessing the ground report on chana production prospects.

The mandi prices of chana, from the early harvest at present, is ruling at around ₹4,600/quintal against the Minimum Support Price (MSP) of ₹5,335/quintal for 2023-24

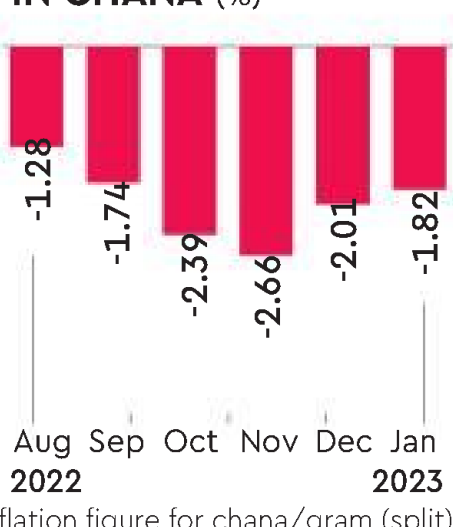


CHANA PRODUCTION (million tonne)

marketing season.

“Because of lower crop prospects, the mandi prices are expected to go up by ₹200/quintal to ₹300/quintal from the current level in the next couple of weeks,” a trader from Gujarat told FE.

The prices are expected to rule around MSP as the government holds around 1.6 MT of chana through the farmers

cooperative Nafed.

“Warm climate at the time of seeding and now high temperatures at the time of harvest may play a vital role in coming days which will ascertain yield prospects for this year’s crop,” Harsha Rai of Mayur Global Corporation, an agri-business firm, said.

Inflation in chana has been consistently in the negative

zone for last many months because of bumper output and surplus stocks held with Nafed.

Inflation in chana declined by 1.81% in January, 2023.

“Nafed is consistently selling its chana stock in the open market since the last many months which has kept the prices of the pulses variety under check,” Nitin Kalantri, managing director, Kalantri Food Products, a Latur, Maharashtra-based processor, said.

Because of record chana production of 13.75 MT in the 2021-22 crop year (July-June), Nafed procured more than 2.5 MT of pulses in the 2022-23 (April-June) season under the price support scheme, aimed at providing minimum support price (MSP) to farmers.

The pulses variety has a share of close to 50% in the country’s production of 27.69 MT in the 2021-22 crop year (July-June).

At present, Nafed has 2.37 MT, which is at par with the government’s buffer stock norm.

Of this, the chana stock is more than 1.6 MT. However, in the case of other varieties of pulses, because of lower procurement, the government’s stocks are smaller – moong (0.5 MT), urad (0.07 MT) and tur (0.05 MT) at present.

●PLASTIC PACKAGING

FIEO seeks clarification for relief to exporters

RECENT IMPORT CARGO norms for plastic packaging are causing port congestion, with industry body FIEO and customs authorities attempting to clear the resulting log-jam, which has also increased port dwell times.

Following amendments to the Plastic Waste Management Rules, 2016, last year, anyone who imports plastic packaging products, carry bags, multi-layered packaging, or plastic sheets must register on the Central Pollution Control Board’s (CPCB) portal.

The initiative aims to reduce the use of single-use plastic. However, these guidelines apply not only to those who import plastic packaging products as end products, but also to those who import primary products such as machinery, textiles, or any article packaged in plastic.

Industry body Federation of Indian Export Organizations (FIEO) has written to the CPCB on the issue noting that as per a February 8, 2023 order of Jawaharlal Nehru Customs House (JNCH), exporters importing raw materials or machines packed or wrapped in plastic bags



and sheets have to apply under Extended Producer Responsibilities (EPR), even though these are non-plastic. “On a perusal of FAQs issued by CPCB, it is found that export-oriented units are exempt from fulfilling EPR obligations.

“However, the Standing Order of Customs is silent on this,” FIEO said.

It has requested a clarification seeking that all non-plastic exporters, who are importing raw materials, machines packed or wrapped in plastic bags and sheets of more than 50 microns, are exempted from formalities related to EPR.

Ajay Sahai, director general and CEO, FIEO, noted that the current norms will

increase transaction time and costs of exporters. “We have requested that the norms should not be applied to those who just have plastic packaging around their goods or are importing plastic packaging to EOUs and SEZ for export purpose or even others who are importing for export purposes,” Sahai said.

According to official sources, the registration is taking up to three to four months noting that this is a new requirement. “Clearance of imported consignments cannot be held up for that long as it would disrupt supply chains and also lead to inflated dwell times in customs clearance,” a source said.

FCI sells 540,000-tn wheat via e-auction

THE FOOD CORPORATION OF India (FCI) on Wednesday sold 540,000 tonne of wheat to private bulk buyers such as flour millers and food companies through the fourth e-auction, taking the total grain sold in open market this year

to 2.35 MT.

More than 1,000 bidders across 23 states participated in the e-auction and the average price of wheat realised by FCI has been ₹2,193.82/quintal against the Minimum Support Price (MSP) of ₹2,125/quintal fixed for the next procurement season (2023-24) beginning on April 1.

Through open market sale, the government is aiming to bring down the mandi prices of wheat to MSP for 2023-24 marketing season (April-June) in the next couple of weeks so that agencies get sufficient volume of grain for procurement.

In the last three auctions held since the beginning of February, FCI has sold 1.8 MT of wheat to bulk buyers.

The government has approved selling 5 MT of wheat to be sold in the open market, which includes 540,000 tonne of grain is allocated to the state governments and agencies such as NAFED, Kendriya Bhandar and NCCF for selling flour (atta) at a maximum retail price of ₹27.50/kg.
